Although our other multi formulas contain vitamin D3 from lanolin, in this product it is not from lanolin, but from a plant source (lichen). This completely vegetarian and vegan vitamin D3 is approved by the Vegan Society and the Vegetarian Society, and is the natural form in which the body produces vitamin D after exposure to the sun.

While many vegan supplements provide vitamin D as vitamin D2 (ergocalciferol, a derivative of ergosterol), vitamin D3 (cholecalciferol) is the form that most in the scientific community believe to be superior.

Vitamins are a group of organic nutrients, essential for regulating chemical processes in the body, and B vitamins are known for their role in obtaining energy and contributing to reducing tiredness and fatigue. In this formula, all vitamins are present in relevant quantities, making it a useful product when, mainly, a medium/high potency B complex is required.

Vitamin D contributes to reducing bone demineralization in postmenopausal women. Low bone mineral density is a risk factor for osteoporotic bone fractures in women aged 50 years and older.

Minerals are inorganic substances that actively participate in regulating a wide range of physiological functions, such as the transport of oxygen to cells and the maintenance of the central nervous system. They are also necessary for the growth, maintenance, repair and well-being of tissues.
